Here are the complete and updated Lists of BIR RDO Codes in the Philippines in 2021 taken from the Bureau of Internal Revenue.All taxpayers, businesses and corporations must know their own BIDO because it is important to know where your tax record is registered. Every taxpayer or business is assigned to a specific sector called Revenue District Office.The BIR (Bureau of Internal Revenue) has a list of RDO Codes in the Philippines to help in monitoring, processing and auditing of tax payments, tax returns, withholding taxes, and other tax accounts.Taxation is a big power of the government so generating the government revenue from taxes is important. Using RDO codes is significant in the computation of taxes collected across the Philippines.How to Use BIR RDO Code?We need to include the correct RDO code in any BIR form we use. The RDO section in every BIR form has three boxes. You fill in the correct code associated with your revenue district office which you can find on the list below.How to Know your RDO?Your RDO (Revenue District Office) is the district in a region where you are presently registered as a taxpayer. If you are working in Makati for example, you must know which RDO in Makati you need to file. Moreover, securing a TIN is not limited to employees but those who wish to start a business or a corporation. It should be noted that most companies these days are the ones who would process their employees' TIN after filling up some forms but if you want to do it yourself, following these steps can get you started. Certain individuals and entities can only secure TIN as long as they belong to the category below: Self-employed and mixed income individualsIndividuals or employees earning purely compensation incomeCorporations, partnerships, including government agencies and instrumentalities (GAI), Local Government Units (LGUs)One time taxpayers with no previously issued TINPersons registering under Executive Order 98 (those securing TIN to transact with government offices.Estates and trusts Requirements Depending on your classification, the requirements and steps may vary in securing your TIN. Read carefully below the classifications of individuals and entities on how to secure your TIN as well as the documents needed. Pay the Documentary Stamp Tax (Php15) and other certification fees as may be deemed necessary.Wait for the RDO to issue your Certificate of Registration. For Individuals Earning Purely Compensation Income Fill up BIR form 1902 provided and submit it along with other requirements needed by the employer.The employer will then fill in the necessary sections of the form.The form will then be forwarded to the RDO having jurisdiction over the place of work where the employee is expected to report. For Corporations and Partnerships Fill up BIR form 1903 and together with the required documents, submit it to the Revenue District Office or RDO.At the Authorized Agent Banks of the RDO, pay the annual registration fee of Php 500. Pay the Documentary Stamp Tax (Php15) and other certification fees as may be deemed necessary.Wait for the RDO to issue your Certificate of Registration.For corporations, Documentary Stamp Tax on the Articles of Incorporation must be paid within 5 days after the close of the month following the date of issuance of the same Articles. For One Time Taxpayers Fill up BIR form 1903 and together with the required documents, submit it to the Revenue District Office or RDO.Be informed that there for one-time taxpayers, there may be different steps, depending on the jurisdiction and nature of the transactions. To be sure ask the officers available for the proper procedure.
