Since 1997, the CFAT was located in California. The RBML contains records from the "New York" period (1904-1980) of the activities of the Foundation. Starting from 2009, the CFAT records are completely processed and online search help is available. Most of the CFAT collection is stored off-site and must be pre-ordered through the curator. This study, entitled Educting Physicians: an invitation to reform medical schools and residence programs, contained four primary recommendations aimed at stimulating innovation and improvement in medical education. In this article, the authors examined the ways for others applied the four recommendations to educate doctors inside and beyond medical education. In their review of 246 publications, citing Carnegie's work, they found that the recommendation of integration was addressed more frequently, often through the descriptions of the integration of curricular content in university medical education. Focus recommendation on the training of professional identity was the second most frequently addressed, followed by standardization and individualization, then investigation, innovation and improvement. Publications relating to these last three recommendations tended to be conceptual rather than descriptive or empirical. Publications have crossed the continuum of medical education (from the medical school to the residence to doctors in practice) and even in other fields, but university medical education received more attention. The authors discuss common topics between citantic publications and opportunities show further discussions and innovation. Many exciting developments have occurred in medical education and beyond the publication of educating doctors in 2010. So far, most of the publications that mention Carnegie's recommendations describe incremental changes in medical education, particularly in the integration sector . Some of the conceptual work around these recommendations, coupled with a variety of external factors such as changes in health care and accreditation systems, suggest the potential of more transformative changes in á €
